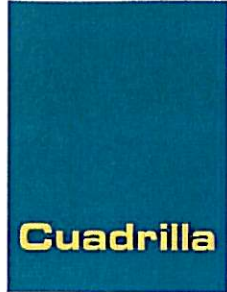

RE: LAND USE AGREEMENT BETWEEN REAPER LIMITED AND CAUDRILLA RESOUCES PERMITTING THE USE OF LANDS NORTH OF MARSH ROAD TO MAINTAIN IN A SUITABLE CONDITION FOR WINTERING BIRDS DURING THE PERIOD 31st OCTOBER 2013 TO 31st MARCH 2014.

Background

Cuadrilla is operating an exploration site for hydrocarbons as authorised by the Planning Permission 08/10/0973. In association with the terms of the amended Planning Permission a management plan is to be implemented to mitigate the impact of the development on ecological interests (overwintering birds). Such a plan, which includes for seasonal restrictions on site development works and measures to avoid impacts on ground nesting birds, to have been submitted to and approved in writing by Lancashire County Council as the Planning Authority. The Planning Authority requires a strategy for protecting the overwintering birds for the exploration site to remain un-restored during the period 31 October 2013 to 31 March 2014 thus providing suitable roosting and grazing for the estuary bird population and land use as described below.

I Paul Smith confirm that Cuadrilla Resources Limited have compensated for Reaper Limited's loss of use of the land North of Marsh Road as per attached plan for a period between the 31st October 2013 and the 31st March 2014 and have my permission to mow the vegetation down to 10cm and maintain in such state. I also confirm that this will be the sole use of the land and I will not carry out any farming activities during the aforesaid period.

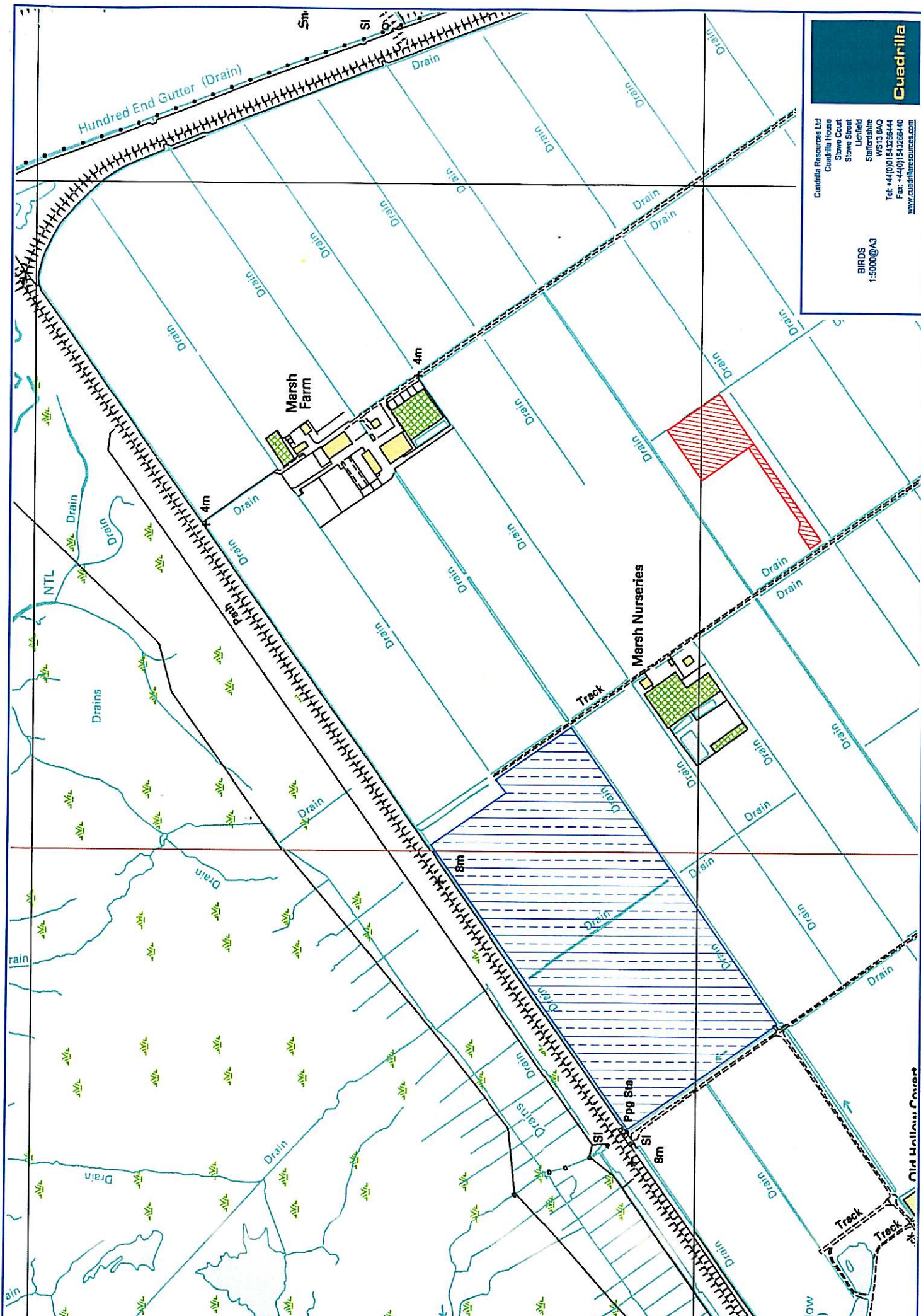
