

LANCASHIRE CRICKET MEMBERSHIP CATCHMENT ANALYSIS

Introduction

- 1. This Technical Note has been prepared by Barton Willmore's Development Economics Team, to examine the Membership Catchment of Lancashire Cricket ('LC') and demonstrates that the proposed facility at Farington provides an optimal location for LC to establish it's second, much needed, purpose-built facility.







Figure 2: Residential location of Lancashire Cricket Club Members (by Postal Area) and location of existing facilities

- 2. Figure 1 shows the location of the percentage of existing LC Members by postal area across the UK. This shows a significant proportion of members located within the North West of England in particular within Manchester, Liverpool, Preston and Blackpool commensurate with the appeal of the game at County level. Figure 2 displays a more detailed view of the location of LC Members within the North West and also shows the location of Emirates Old Trafford ('EOT') which is LC's only permanent base at present alongside other existing out grounds which are currently used by LC when EOT is unavailable. This includes: Aigburth, Blackpool CC, Chester Broughton hall CC, Sedbergh School, and Southport and Birkdale CC. It is relevant to note that none of the existing facilities used by LC are located within the County of Lancashire (shown by the blue boundary).



Figure 1: Residential location of Lancashire Cricket Members (by Postal Area)

- 3. We have examined the respective catchment areas of EOT and the existing outgrounds utilised by LC by adopting a one hour peak drivetime from each location alongside a 20km and 25km radius and calculated the percentage of members located within each.




Figure 3: One hour peak drivetime from the existing facilities

- 4. The results of this analysis are shown in Figure 3 and Table 1. In summary, 83.92% of LC Members reside within a one hour drivetime of EOT. This is reflective of EOT being LC's main base and home to the most significant County matches. By comparison, between 65-78% of Members reside within a one hour drivetime of Aigburth, Blackpool CC, Chester and Broughton



Hall CC, and Southport and Birkdale CC out grounds. A much lower proportion of 17.53% Members reside within a one hour drivetime of Sedbergh School.




Figure 4: One hour peak drivetime from Farington

5. Figure 4 shows the same analysis applied to the Farington Site. This shows a significant 88.84% of LC Members falling within a one hour drivetime of the Site which exceeds even that currently achieved by EOT (at 83.92%). This is attributed to the Site's location, uniquely relative to all existing venues, within Central Lancashire (and good links to the strategic road network).




Figure 5: 20km radius from the existing cricket grounds

6. Figures 5 and 6 show a 20km and 25km radius respectively, from the existing facilities used by LC and Table 2 shows the proportion of LC Members falling within each catchment. This reinforces the strength and appeal of EOT which serves a significant 75% of Members from with a 25km radius. None of the existing outgrounds achieve anywhere near this level, with the next highest, Southport and Birkdale CC serving 35% of Members within a 25km radius.

Figure 6: 25km radius from the existing cricket grounds





7. Figure 7 applies the same analysis to the Farington Site. Within 20km, the Site serves 27.31% of existing LC Members. The percentage of members significantly increases within a 25km radius to 57.57%, as shown in Table 3. Whilst this does not match the localised draw of EOT, it clearly performs much better than any of the existing outgrounds.

Dear Councillor Williamson,

I hope all is well with you. On behalf of Lancashire Cricket, I am delighted to write to formally support the proposed Farington elite and community cricket project.

I am very excited by the collaboration between Lancashire Cricket and Lancashire County Council which will deliver a valuable asset for the local community and wider county and ensure high-quality professional facilities for the club in Lancashire. Bringing professional cricket into the heart of the county will help to drive recreational, youth and women's sports and also support the health and wellbeing agenda. The Club as you know is a Community and Benefit Society and has no shareholders and so no dividends or profit distributions. All surpluses are reinvested into people and facilities which support the Club's cricketing and community objectives.

The proposed new ground in Farington will be Lancashire Cricket's second home and will encourage sport, fun, participation and activity in a safe and managed environment. The facility will become a Centre of Excellence for Women's Cricket in the North-West of England, further encouraging the growth of cricket in the region. The second pitch will be dedicated to community use and training purposes.

Demands on the main pitch and practice facilities at Emirates Old Trafford have increased significantly over the last few years. Gone are the days when men's First and Second XI cricket plus one Test Match were the sum total of usage. We now need to provide playing and practice facilities for all our Senior men's and women's teams, our Academies (boys & girls), England Test and ODI/IT20 matches, international teams who may need to use the ground and on-site Hilton Hotel as a secure training base and finally for the Hundred competition, with the Manchester Originals (men & women) training and playing at Emirates Old Trafford.

The ground and nets at Emirates Old Trafford provide a finite resource which has been taken beyond its limits over the past few years, as the amount of cricket being played has increased dramatically. Currently, by the end of the summer, the nets and square at Emirates Old Trafford are virtually worn out and not far from being unusable for quality practice. This is not ideal for one of English cricket's top professional teams looking for on-pitch success. The forecasted 130 days of match day and practice is already beyond the scope of the current facility.

The Farington site has the potential to become the pre-eminent example of a modern development ground for County Cricket and by extension participation and elite sport country wide. With enough space for two grounds, a Pavilion, and a nets facility, in addition to being in the heart of Lancashire and accessibility to major roads, it is why Farington is the preferred option for this facility. The intention is for the facility to bring community and elite sport together. It will support the development of community and youth cricket for boys and girls.

Whilst the second pitch will be used for training, it will also be made available to the community, which could be for recreational cricket clubs or schools. Lancashire's Disability Team will also make use of the facilities available





at Farington. The new facilities will help to support additional health and wellbeing opportunities through active participation in sport and will help the Lancashire Cricket Foundation deliver a number of nationwide cricket programmes that they run such as All Stars Cricket and the Dynamos Cricket programme. All have the aim of increasing participation in the game of cricket. It is assumed that fixtures for many user groups would not be ticketed and would form part of the typical day-to-day usage of the site. These include the following:

- Up to 15 games for Lancashire women's teams.
- Up to 15 Second XI fixtures.
- Up to 15 Academy fixtures throughout the summer.
- Up to 200 age-group fixtures throughout the summer.
- Up to 20 Disability fixtures throughout the summer.

As well as providing new sports facilities, a number of new jobs, training and skills opportunities will be created for local people. The development will create up to 30 new job opportunities, in addition to those generated during the construction process.

The proposed uses on the site have been designed to minimise impacts on neighbouring residents, the local community and to preserve the nature of the Green Belt setting. The Club was looking for a site in the heart of Lancashire, which is easily accessible for all those involved, including Players, Coaching and other support Staff, Members and Supporters for when fixtures are taking place at the venue. Farington is exactly that, given its proximity to the A6 and M6, and the availability of a train station a short distance away in nearby Leyland.

The England and Wales Cricket Board (ECB) fully support the project. The project also meets the ECB's standards for elite professional Cricket for both Men and Women and the proposed designs are fully compliant with all relevant ECB and Sport England standards. The designs also reflect the stated aims of the project by including 'best practice' for creating a welcoming environment for all.

In conclusion, the Club is delighted to be working with Lancashire County Council on this exciting community-focused project and the Board has approved formal support to the planning submission.
